REGULATIONS FOR THE IMPORTATION OF FROZEN BUFFALO MEAT (DEBONED AND DE-GLANDED) FROM INDIA WITH WORLD ORGANIZATION FOR ANIMAL HEALTH (WOAH) RECOGNISED FOOT AND MOUTH DISEASE FREE ZONE INTO

SARAWAK, MALAYSIA (Effective 3 April 2023)

A. Product : Buffalo Meat (Deboned and deglanded)

B. Zone and Country of Export : Aurangabad & Solapur, Maharashtra State, India

C. Purpose : Human consumption

D. Regulations for importation

1) Source of buffalo for slaughter

All animals at the abattoir holding yards should come from farms certified by a competent veterinary authority of the Government of India to be healthy and free from Foot and Mouth Disease (FMD) and Anthrax for the past six months.

2) Procedures to be adopted at the approved abattoir

- a) Slaughter should be carried out at the approved abattoir and animals for slaughter should be examined daily from FMD and other infectious and contagious diseases.
- b) Feed for animals in the holding yards should be obtained from FMD free areas.
- c) The entire consignment for export to Sarawak at the abattoir holding yards must be rejected in the event that FMD is detected. Reintroduction of animals for the purpose of export to Sarawak should only be undertaken after thorough disinfection of the holding yards under the supervision of competent veterinary authority of the exporting country and not less than two weeks after disinfection has been completed.
- d) In the event that FMD is detected during meat inspection, the entire consignment for export to Sarawak must be rejected followed by disinfection of the abattoir and holding yards under the supervision of competent veterinary authority of the exporting country.

3) Certification

The consignment should be accompanied by the following documents:

- A certificate certifying that the animals in the holding yards are healthy and free from FMD and Anthrax.
- b) The origin of buffalo is derived from **Maharastra state** where an official control for FMD exists and approved by WOAH.
- c) The country of origin for buffalo meat beside fulfilling requirement aforementioned in point a shall come from the country of origin free from Contagious Bovine Pleuropneumonia, Rift Valley Fever and come from the country of origin negligible Bovine Spongiform Encephalopathy.
- d) A meat inspection certificate certifying that the meat has been derived from animals subjected to ante-mortem and postmortem examination and had been found to be free from infectious and contagious diseases.
- e) That every precaution had been taken to prevent contamination with treatments preservatives, colouring matter or other foreign substances prior to export.
- f) A certificate that the meat comes from deboned carcass
 - i) from which the major lymphatic nodes have been removed.
 - which prior to deboning, have been submitted to maturation at a temperature greater than +2°C -+10°C for a minimum period of 24 hours, following slaughter and in which the pH value was less than 6.0 when tested in the middle of both the longissimus dorsi muscle individually.
- g) The meat is free from parasitic infestation and pathogenic organism.
- h) The buffalo meat is in wholesome and passed sanitary requirement
- 4) An Official Halal certificate certifying that the slaughter of animals has been done according to Muslim rites and that all slaughtering processes, chilling, processing, transportation and all other acts in connection with handling and consignment of the meat has been done according to standard operating procedures and separated from the other species of animals.

- 5) Product inner and outer packaging must be labeled or clearly printed on the packing with
 - a) Name and address of establishment number
 - b) Establishment number of the abattoir,
 - c) Batch number and date of slaughter
- 6) The consignment must have official seal intact and untampered with in anyway on the container(s) and the **original** documents must be surrendered on arrival.
- 7) Upon arrival, all meat will be inspected and sampled at random at the port of entry and released only after the Sarawak Veterinary Authority is satisfied with the visual inspection, testing and documentation.
- 8) The consignment will be subjected to "Hold Test Release" to ensure it comply with the requirement
- 9) The premises where the meat is stored shall be subjected to inspection by the Department of Veterinary Services Sarawak (DVSS).
- 10) The consignment must not exceed the microbiological limits as below.

REGULATIONS FOR THE IMPORTATION OF BEEF, MUTTON, LAMB AND VENISON AND PART THEREOF FROM OVERSEAS INTO SARAWAK, MALAYSIA (Effective from 3 April 2023)

A. Product : Beef, Mutton and Chevon

B. Country : All countries

C. Purpose : Human consumption

D. Requirements for importation:

1. Import Permit

The consignment of meat shall be accompanied by a valid import permit issued by the State Veterinary Authority (SVA) permitting the importation of such meat into Sarawak.

2. Veterinary Health Conditions

The consignment of meat shall meet the following health conditions as supervised by the competent authority of the exporting country.

- a. The animal were slaughtered and processed in an approved slaughtering and processing plant which has been inspected and approved for export by the Department of Veterinary Services (DVS), Malaysia and has been under continuous supervision of the Veterinary Authority of the exporting country.
- b. Exporting country is free from contagious bovine pleuropneumonia, bovine brucellosis, foot and mouth disease (without vaccination), haemorrhagic septicaemia, rift valley fever, lumpy skin disease and vesicular stomatitis for the past twelve (12) months prior to export.
- c. Exporting country is recognized as having a negligible bovine spongiform encephalopathy (BSE) risk in accordance with the BSE chapter in current World Organization For Animal Health (WOAH) Recognised Code.
- d. Meat is derived from animals that have not originated from properties quarantined due to anthrax or any other infectious or contagious diseases.
- e. The animals from which meat were derived were of exporting country origin.
- f. The feeding of ruminant protein to ruminants is prohibited in exporting country.
- g. Prior to slaughter, the animals have been examined (ante-mortem inspections) and found to be healthy and free from any clinical signs of infectious or contagious diseases.
- h. The slaughtered animals were subjected to post-mortem meat examination and found to be free from foot and mouth disease and other infectious or contagious disease lesions in accordance with international standard of meat inspection procedures.
- The carcass shall be dressed, eviscerated and processed at the DVS Malaysia approved abattoir before the meat is exported to Sarawak.

Processing may include:

- i. Boning of the carcase before the temperature at the thermal centre of the carcase is reduced to 20°C or; 2.9.2 Boning of the carcase following initial chilling.
- ii. The carcasses should be processed, packed and stored at DVS approved processing plant under sanitary conditions.
- j. The meat has met microbiological standards of exporting country and is free from pathogens and other harmful contaminants and residues.
- k. Every precaution had been taken to prevent contamination, treatment with preservatives / colouring matters or any other harmful material and that the meat is fit for human consumption.
- Product inner and outer packaging must be labeled or clearly printed on the packing with
 - a. Name and address of establishment number
 - Establishment number of the abattoir,
 - c. Batch number and date of slaughter

3. Certification

- a. Health Certification
 - The consignment of meat shall be accompanied by a veterinary health certificate certifying the above veterinary health conditions issued by the competent veterinary authority of exporting country within 7 days prior to export;
 - ii. The certificate contains details of the following:
 - Export establishment number where slaughtered
 - 2. Name and address of the exporter
 - 3. Description of goods:
 - Number and kind of packages

- Date of departure
- Quantity of meat (kg)

b. Halal certification

- i. The consignment of meat shall be accompanied by a Halal Certificate issued by Halal Certification Body recognized by JAKIM confirming that the slaughter of the animals has been done according to the Malaysian Protocol for Halal Meat and Poultry Production. Adequate precautions have been taken to prevent mixing with non-halal conformance carcasses during slaughtering, deboning, chilling, freezing, packaging, storing, transportation and all other acts in connection with handling and consignment.
- The certificate contains details of the following;
 - 1. Name and establishment number of the abattoir
 - Description of meat;
 - Number and kind of packages
 - · Date of slaughter
 - Quantity of meat (kg)

4. Transportation and Landing Place

- a. The refrigerated vehicle/container used for the transportation of the meat must be in hygienic conditions and at temperature maximum 4°C for chilled or -18°C for frozen.
- b. During transportation, Halal product shall be identified and segregated in complete packaging, from non-Halal conformance product.
- c. Each consignment of products imported into Sarawak shall be carried by ship or aircraft or any vehicle direct to the prescribed landing place in Sarawak.

5. Other Conditions

- a. The inner and outer packaging of the product must be labelled with logo of registered Islamic Organisation in exporting country that has been approved by Malaysian Authority. The name, address, establishment number of the abattoir, batch number and date of slaughter must also be labelled in the packaging.
- b. The approved abattoir shall be subjected to inspection by the Department of Veterinary Services Malaysia (DVS), State Veterinary Authority and Department of Islamic Development Malaysia (JAKIM) at any time as and when deemed necessary.

6. Suspension of Import

State Veterinary Authority may at any time when deemed necessary suspend the importation either temporarily or permanently in the event of disease outbreaks or suspected disease outbreaks or in case of importation in contravention of the above requirements.

7. Right to Amend Import Requirements

State Veterinary Authority reserves the right to amend the above requirements at any time as he may deem necessary in consultation with the exporting country competent authority and allowing appropriate time for transition and implementation.

REGULATIONS FOR THE IMPORTATING OF COOKED OR HEAT-PROCESSED BEEF OR MUTTON PRODUCTS FROM WEST MALAYSIA AND SABAH INTO THE STATE OF SARAWAK, MALAYSIA (Effective from 3 April 2023)

A. Animal

Cooked and Heat-processed beef or mutton products

B. Country of export

West Malaysia and Sabah

C. For the purpose of

Human Consumption

D. Regulation for Importation: -

1. Import Permit

Each consignment of cooked and heat-processed beef or mutton products shall be accompanied by a valid import licence issued by the State Veterinary Authority, Department of Veterinary Services Sarawak permitting entry into Sarawak, Malaysia.

- 2. The processing plants must be accredited under the Veterinary Health Mark accreditation programme.
- 3. The Establishment number and Name of processing plants must be clearly stamped on every cartoon.

4. Packing and Labelling

- a. The individual packing must bear the following:
 - i. Establishment Number, name and Address of processing plant or manufacturer.
 - ii. Name and address of importer.
 - iii. Veterinary Health Mark (VHM) logo.
 - iv. Date of Packing and Best Before

5. Veterinary Health Certification

Each consignment of cooked and heat-processed beef or mutton products shall be accompanied by the following certificates dated within thirty (30) days of import:-

- a. Halal Certificate issued by Jabatan Agama Islam Negeri certifying that the products are halal are fit for Muslim consumption.
- b. Veterinary Health Certificate signed by competent veterinary officer of the Department of Veterinary Services, Malaysia certifying that:
 - i. the products were derived from farms in which no case of infectious or contagious disease notifiable in the country of export has been diagnosed for the preceeding six (6) months prior to the date of export;
 - ii. the cooked and heat-processed beef or mutton products were derived from animals that have been subjected to ante-mortem and post-mortem inspection and were found to be healthy and free from any clinical sign of infectious or contagious disease at the time of slaughter;
 - the cooked and heat-processed beef or mutton products were processed, packed and stored under sanitary condition and do not contain any preservative or colouring matter not permitted under the Food Act, 1983 and Regulation, 1985 and residue or any foreign substance or harmful material injurious to health and that every precaution had been taken to prevent contamination during processing, packing, storing and handling prior to export;
 - iv. the products have been subjected to a heat treatment process to reach a minimum core temperature of the products as follow:
 - 1. 70°C for minimum of 30 minutes or
 - 2. 75°C for minimum of 5 minutes or
 - 3. 80°C for minimum of 1 minutes or
 - 4. 170°C for minimum of 30 seconds.
 - v. the cooked and heat-processed beef or mutton products are wholesome and fit for human consumption.

6. Meat Safety and Quality

All meat must be acceptable quality and meet microbiological standards of Food Act, 1983 and Regulation, 1985 and free from pathogens such as *Salmonella spp., Campylobacter jenuni, Listeria enterocolitica* and other harmful contaminants and residues.

7. For cooked meat products ready for consumption, excluding meat and meat products in hermetically

sealed containers, the microbiological limits as stated below should be negative for Salmonella spp., Campylobacter jenuni, Listeria monocytogenes;-

8. Testing on arrival.

The consignment may be subjected to sampling and testing on declaration.

9. Transportation

Each consignment of heat-processed beef or mutton products or parts imported into Sarawak, Malaysia shall be carried by ship, aircraft or any vehicle direct to the prescribed landing in place in Sarawak, Malaysia.

10. Surrender of Official Documents in Malaysia.

Upon arrival in Sarawak, Malaysia all official documents required under each importation shall be surrendered for verification to the State Veterinary Authority, Sarawak or to any authorized officer assigned by State Veterinary Authority, Sarawak.

11. Amendment

The State Veterinary Authority reserves the right to amend or revise further rules and regulations pertaining to the import of said products into Sarawak, if there are changes in Sarawak's import policy, or for any reason, as and when deemed necessary.

REGULATIONS FOR THE IMPORTATION OF MILK AND MILK PRODUCTS INTO THE STATE OF SARAWAK, MALAYSIA (Effective from 3 April 2023)

A. Products

Liquid milk, yogurt, milk powder, cheese, butter, ice-cream or

milk / dairy products thereof

B. Country of export:

All Countries

C. Purpose

For Human Consumption

D. REGULATION FOR IMPORTATION

- 1. Each consignment of milk and milk products shall be accompanied by a valid import permit issued by the State Veterinary Authority, Department of Veterinary Sarawak permitting into Sarawak, Malaysia.
- 2. Product manufactured in Malaysia must be from accredited processing plants under the Veterinary Health Mark accreditation programme.
- 3. Product (except confectionary) manufactured in oversea must be from List of Dairy Establishments Approved for Export to Malaysia by Department of Veterinary Service Malaysia.
- 4. Veterinary Health Certification
 - 4.1. Milk and milk products
 - 4.1.1.Each consignment of milk and milk products shall be accompanied by Veterinary Health Certificate dated within thirty (30) days of import and signed or endorsed by competent veterinary officer of the Government Veterinary Authority of the country of exporting certifying thatthe country or part of country or state of origin has been free from
 - 4.1.1.1. Foot and Mouth disease.
 - 4.1.1.2. Peste Des Petits Ruminants.
 - 4.1.1.3. Contagious Bovine Plueropneumonia,
 - 4.1.1.4. Contagious Caprine Plueropneumonia and
 - 4.1.1.5. Bovine Spongioform Encephalopathy

for the past twelve (12) months prior to and till the date of export;

**(Country of origin refers to the country where the milk is produced)

- 4.1.2.the milk and milk products were derived from animals (cattle or goats) that have been examined, tested and certified to be free from *Tuberculosis* and have been domicilied in the country of export in the preceding twelve (12) months prior to export;
- 4.1.3.the animals were found to be healthy and free from any clinical sign of infectious or contagious disease (including ectoparasites) at the time of milking;
- 4.1.4.that the milk has been subjected to one of the following procedures to inactivate the viruses present in milk and cream for human consumption, in accordance with Article 3.6.2.5 of the International Animal Health Code 2002.
 - 4.1.4.1. Ultra-high temperature (UHT) (UHT = minimum temperature of 132°C for least 1 second)
 - 4.1.4.2. If the milk has a pH less than 7.0, simple high temperature short time pasteurisation (HTST);
 - 4.1.4.3. If milk has a pH of 7.0 or over, double HTST treatment is required
- 4.1.5.all necessary precautions were taken after processing to avoid contact of the products with any potential sources of FMD virus.
- 4.1.6.the milk and milk products were processed and packed in the processing or packing plant that has been approved for export. The name, address, establishment number of the plant, batch or lot number and date of production must be clearly stated in the certificate:
- 4.1.7.the milk and milk products were processed, packed and stored under sanitary condition and do not contain any preservative, colouring matter, residue or any foreign substance or harmful material injurious to health and that every precaution had been taken to prevent contamination during, the processing, packed, stoking and handling prior to export;
- 4.1.8.that the milk and milk products has been subjected to pasteurization, ultra-heat treatment or sterilization and was packed direct into satisfactory clean and sterilized bottle or container and fulfil the microbiological limits as stated in clause (7) in this permit;
- 4.1.9.that the milk or milk products destined for export to Sarawak, Malaysia are wholesome and fit for human consumption.

4.2. For confectionary containing dairy or milk products

- 4.2.1. The confectionary items consignment containing milk and milk products
 - 4.2.1.1. from oversea
 - 4.2.1.1.1. shall be accompanied by exporting country Government Veterinary Authority certifies that the product is manufactured using milk and milk products originated from FMD free country.
 - 4.2.1.2. from West Malaysia or Sabah (Origin from oversea and reexport)
 - 4.2.1.2.1. copy Government Authority from country of origin that the confectionary items is manufactured using milk and milk products originated from FMD free country, or
 - 4.2.1.2.2. copy of Certificate of Origin from ASEAN Australia New Zealand Free Trade Zone Area if the origin of confectionary is made in Australia.

5. Transportation

- 5.1. Each consignment of milk and milk products imported into Sarawak, Malaysia shall be carried by ship or aircraft or any vehicle direct to the prescribed landing place in Sarawak.
- 6. Surrender of Official Document in Sarawak, Malaysia
 - 6.1. Upon arrival upon in Sarawak, Malaysia, all official documents required under each importation shall be surrender for verification to the State Veterinary Authority or his representatives.

7. Other Conditions

- 7.1. All applications for importation of milk and milk products into Sarawak, Malaysia shall be by writing direct to State Veterinary Authority, Department of Veterinary Sarawak. All importers must be through the local agent or a Malaysian registered company;
- 7.2. The State Veterinary Authority has the right to enquire for any document or detail information from the parties concerned. In the event that the applicants (importer or exporter) fail or unable to provide or to comply with any of the above requirements, the State Veterinary Authority has the right to reject or not to approve the application;
- 7.3. The processing or packing plant shall be subjected to inspection by the official(s) from the State Veterinary Authority prior to approval as and when deemed necessary. All costs incurred shall be borne by the parties concerned:
- 7.4. Each consignment of milk and milk products imported into Malaysia shall be subjected to veterinary inspection by the authorized officer(s) of the State Veterinary Authority at the port of disembarkation or point of entry on arrival in Malaysia. Random samples will then be collected for laboratory testing and State Veterinary Authority has the right to reject, destroy or further detain any consignment when deemed required.
- 8. Failure to comply with any of the above conditions will result in the consignment being rejected on arrival or on inspection on board ship; the consignment shall not be landed and the importer shall bear the cost of sending the consignment back.
- 9. Microbiological Limit

REGULATIONS FOR THE IMPORTATION OF BREEDER DAY-OLD CHICKS FROM FRANCE INTO SARAWAK, MALAYSIA (Effective 3 April 2023)

A. Animal : Broiler breeder day-old-chick

B. Country of export : France

C. Purpose : Breeding

D. Regulations for importation:

1. Import Permit

Each consignment of day-old chicks shall be accompanied by a valid import permit issued by the State Veterinary Authority permitting the importation into Sarawak.

2. Veterinary Certification

Each consignment of day-old chicks shall be accompanied by a veterinary health certificate dated within seven (7) days of import. The certificate shall contain a full description or identification of the DOC and signed by a competent veterinary officer of the Government Veterinary Authority of the exporting country certifying that;

- 2.1. The country or part of the country or state of origin or the free compartment (more than 50km radius of outbreak area) which has been continuously free from Newcastle disease for the past twelve (12) months prior to and till the date of export.
- 2.2. The state of origin or the free compartment (more than 50km radius of outbreak area) which has been continuously free from High pathogenic avian influenza for the past twelve (12) months prior to and till the date of export.

OR

2.3. The state of origin or the free compartment (more than 50km radius of outbreak area) of the day-old chicks has been continuously free from Notifiable Avian Influenza for the past twelve (12) months prior to and till the date of export.

AND

- 2.4. The additional PCR avian influenza tests have been performed in the 14 days prior to export on a sufficient number of animals from flocks of origins of day-old chicks to detect 5% prevalence of disease with 95% confidence level.
- 2.5. The chicks were hatched from eggs derived from a registered farm which is accredited to be free from Salmonella pullorum, Salmonella enteritidis, Salmonella gallinarum, Salmonella typhimurium duck viral enteritis and duck viral hepatitis; and no case of Fowl Cholera, Infectious Bronchitis, Infectious Laryngotracheitis, Infectious Bursal Disease, Marek's Disease, Egg Drop Syndrome, Swollen Head Syndrome, Avian Encephalomyelitis and Mycoplasmosis had been diagnosed or occurred on the farm in the preceding six (6) months prior to export.
- 2.6. The chicks were hatched in a hatchery approved by the veterinary competent authority of the country of export and all eggs incubated in the same incubator at the same time come from registered farms by veterinary competent authority which comply with requirement 2.2-2.4.
- 2.7. The eggs and incubators used in the hatchery have been fumigated and disinfected prior to incubation.
- 2.8. The chicks were packed direct from the incubator in the hatchery into satisfactory clean and new disposable boxes for export, and had no contact with any bird other than day-old chicks originating from the same hatchery.
- 2.9. The day-old chicks destined for export to Sarawak have not been vaccinated OR have been vaccinated using vaccine that approved by the veterinary authority of the exporting country against Marek's disease only or with other common poultry diseases vaccination (The list of disease vaccinated and date of vaccination shall be listed in the certification)

2.10. The day-old chicks destined for export to Sarawak have been examined by the registered veterinarian and found to be healthy and free from any clinical sign of infectious or contagious disease at the time of export.

3. Transportation and Landing Place

Each consignment of day-old chicks imported into Sarawak shall be carried by ship or aircraft or any vehicle direct to the prescribed landing place in Sarawak.

4. Other Conditions

- 4.1. The consignment of day-old chicks shall be subjected to veterinary inspection by the authorized officer at the point of entry on arrival in Sarawak. In the case if the chicks are not healthy or suspected to be or have been infected with any disease or if any document is not in order, the authorized officer has the right to reject, destroy or further detain any consignment when deemed necessary.
- 4.2. The farm and hatchery will be subjected to inspection by the officials from the Department of Veterinary Services Sarawak as and when deemed required.

5. Suspension of Import

The State Veterinary Authority may at any time when deem necessary to suspend importations either temporarily or permanently in the event of disease outbreaks or suspected disease outbreaks or in case of importation in contravention of the above regulations.

6. Right to Amend Import Regulations

The State Veterinary Authority shall amend the above conditions at any time as he may deemed necessary.

A. Poultry : Day Old Breeder Chicks, Day Old Duckling, Day Old Layer Chicks,

Day old goosling, Day old turkey

B. Country of export : West Malaysia and Sabah

C. Purpose : Rearing or Breeding D. REGULATION FOR IMPORTATION

1) Import Permit

- a) All application to import of day-old chicks into Sarawak shall be made to the State Veterinary Authority, Department of Veterinary Services, Sarawak giving details of the names and address of farm of origin, name and address of exporter, country of export, number of birds, breed and age of birds to be imported, purpose of import, means of transport, name and address of importer, name and address of farm(s) where the imported birds are to be kept or reared.

3) Veterinary Health Certification

Every consignment of the day-old chicks imported into Sarawak shall be accompanied by a veterinary certificate issued by a competent veterinary officer from local government veterinary authority attesting

- a) the birds came from farm(s) which is **Certified under Malaysia Good Agricultural Practices (MyGAP)** and is under regular health inspection by a veterinarian with relevant avian experience;
- b) The farm is under intensified government surveillance programme on Avian Influenza and has been tested and found to be free from Avian Influenza;
- c) The poultry were derived from breeder/layer flocks which had been kept in *Avian Influenza (AI)* free farm for twenty-one (21) days prior to and at time of the collection of the chicks/eggs;
- d) The poultry were kept in Avian Influenza (AI) free farm since they were hatched;
- e) The poultry originated from establishment that have no outbreak of *Newcastle Disease (ND)* for the past six (6) months and not stated in any ND infected zone;
- f) The birds have been inspected and found to be free from any clinical sign of infectious or contagious disease of birds within forty-eight (48) hours of export by a Government Veterinarian;
- g) There have been no clinical or pathological evidence of the following diseases on the premises or farm(s) of origin within the preceding 6 months prior to export:
 - i) Velogenic Newcastle Disease
 - ii) Pathogenic Avian Influenza
 - iii) Fowl Cholera
 - iv) Infectious Laryngotracheitis

- v) Infectious Bursal Disease
- vi) Fowl Pox
- vii) Infectious Bronchitis
- viii) Infectious Coryza

- h) All the birds destined for export to Sarawak were hatched from eggs from breeder flocks free from Pullorum disease, the farm should have certification that it has pullorum screen programme and is free from pullorum disease (Fowl Typhoid, Salmonella enteritidis and Salmonella typhimurium).
- i) No clinical evidence of velogenic Newcastle disease, pathogenic Avian Influenza, Fowl Cholera, Marek's disease, avian leukosis and salmonellosis have been detected in the breeder flock(s) of during the preceding six (6) months prior to export.
- j) That all layer and breeder chicks were vaccinated against Marek's Disease.

4) Transportation and landing Point in Sarawak.

- a) Every consignment of day-old chick imported into Sarawak shall be transported by aircraft direct from the airport of embarkation in the country of export to the prescribed landing point or airport of disembarkation in Kuching International Airport, Sarawak. Transit at Kuala Lumpur International Airport is permitted; however, transit time should not be more than 24 hours.
- b) Containers used to transport birds should meet International Air Traffic Association regulations,
- c) Relevant tests will be conducted at the entry port and samples will be collected for laboratory tests when necessary.
- d) The birds will be required to undergo quarantine at premises approved by the State Veterinary Authority for minimum period of 14 days.
- e) During quarantine, the birds will subject to monitoring and testing by State Veterinary Authority, Department of Veterinary Services, Sarawak or his representative as when required before release.

5) Surrender of Official Documents in Sarawak.

a) Upon arrival in Sarawak, all official documents required under each importation shall be surrendered for verification to the State Veterinary Authority or to any authorized officer assigned by the State Veterinary Authority, Department of Veterinary Services Sarawak as the officer in charge at the relevant airport / port of entry.

- the country/state of export is free from Bovine Spongiform Encephalopathy (BSE) and Transmissible Spongiform Encephalopathy (TSE)/prion, Scrapie or in the case that the country is not free from BSE, TSE and Scrapie, no cattle, buffalo deer, sheep and goat have been used to manufacture the pet food.
- iv. there has been no outbreak of African Swine Fever, Foot and Mouth Disease (FMD) and Highly Pathogenic Avian Influenza (HPAI) within 10 km radius of the manufacturing facility.
- v. pelletized / crumbled animal, fish and shrimp feed referred in the certificate has been manufactured according to standard processing technique and has been subjected to heat treatment to reach an internal core temperature of at least 70 degrees centigrade for a period of not less than 30 minutes or to any equivalent treatment which has been demonstrated to kill virus and bacteria.
- vi. All necessary precaution has been taken to prevent contamination of the animal feed referred in the certificate from pathogens.
- vii. the product from African Swine Fever infected countries/states must not contain pork or pork product.

b) For import from West Malaysia

- Animal, pet food, fish and shrimp feed (including feed additives such as vitamins, minerals) <u>manufactured</u> in West Malaysia must comply to Feed (Manufacture and Sale of Feed or Feed Additive) Regulations 2012.

 - b. Veterinary Health Certificate from Department of Veterinary Service Malaysia certifying that there has been no outbreak of African Swine Fever, Foot and Mouth Disease (FMD) and Highly Pathogenic Avian Influenza (HPAI) within 10 km radius of the manufacturing facility.

A. Animal : Cattle / Buffalo

B. Place of export : Australia/New Zealand

C. Purpose : Slaughter

D. Regulations for the importation: -

1. Import Permit

Each consignment of any other animals shall be accompanied by a valid import permit issued by the State Veterinary Authority, Department of Veterinary Services Sarawak permitting entry into Sarawak, Malaysia.

2. Description of animal

The consignment of any other animals or birds shall be accompanied by a certificate containing a full description or identification of the animals.

3. Veterinary Certification

- a. The animals must come from area or District or State which has no clinical cases of the following diseases for the last 12 months.
 - i. Bovine Spongiform Encephalopathy
- iii. Camphylo Bacteriosis
- ii. Contagious Bovine Pleuropneumonia
- b. Within 30 days of export, the animal must be negative on serological testing for:
 - i. Brucellosis (CFT & SAT)
 - ii. Johne's Disease
 - iii. Melioidosis (CFT)
- These tests can be waived if the Veterinary Authority of exporting country can certified clinically free of these diseases.
- 4. Within sixty (60) days of export, the animal must be submitted to the intradermal tuberculin testing with negative result or certification that the farm is bovine tuberculosis free.
- 5. Once dipping or spraying with approved ascaricide one week before export.
- 6. Animals to be dewormed before export.
- 7. A single injection of Streptomycin Sulphate before export.
- 8. Advance notice of the expected time of arrival should be made known to the State Veterinary Authority, Kuching at the number below.

Each consignment of animal products shall be accompanied by a valid import licence issued by the State Veterinary Authority, Department of Veterinary Services Sarawak permitting entry into Sarawak, Malaysia.

- 2) The processing plants must be accredited under the Veterinary Health Mark accreditation programme.
- 3) The Establishment number and Name of processing plants must be clearly stamped on every carton.

4) Packing and Labelling

- a) The individual packing must bear the following:
 - i) Establishment Number, name and Address of processing plant or manufacturer.
 - ii) Veterinary Health Mark (VHM) logo.
 - iii) Date of Packing and Best Before (expiry date)

5) Veterinary Health Certification

Each consignment of cooked and heat-processed poultry products shall be accompanied by the following certificates dated within thirty (30) days of import:-

- a) Halal Certificate issued by Jabatan Kemajuan Islam Malaysia certifying that the products are halal are fit for consumption of Muslims.
- b) Veterinary Health Certificate signed by competent veterinary officer of the Department of Veterinary Services certifying that:-
 - the products were derived from farms in which no case of infectious or contagious disease notifiable
 in the country of export has been diagnosed for the preceding six (6) months prior to the date of
 export;
 - ii) the cooked and heat-processed poultry products were derived from animals that have been subjected to ante-mortem and post-mortem inspection and were found to be healthy and free from any clinical sign of infectious or contagious disease at the time of slaughter;
 - iii) the cooked and heat-processed poultry products were processed, packed and stored under sanitary condition and do not contain any preservative or colouring matter not permitted under the Food Act, 1983 and Food Regulations, 1985 and residue or any foreign substance or harmful material injurious to health and that every precaution had been taken to prevent contamination during processing, packing, storing and handling prior to export;
 - iv) the products have been subjected to a heat treatment process to reach a minimum core temperature of the products as follow:
 - (1) 70°C for minimum of 30 minutes or
 - (2) 75°C for minimum of 5 minutes or
 - (3) 80°C for minimum of 1 minutes or
 - (4) 170°C for minimum of 30 seconds.
 - v) the cooked and heat-processed poultry products are wholesome and fit for human consumption.

6) Meat Safety and Quality

- a) All meat must be acceptable quality and meet microbiological standards of Food Act, 1983 and Food Regulations, 1985 and free from pathogens such as Salmonella spp., Campylobacter jejuni, Listeria enterocolitica and other harmful contaminants and residues.
- b) For cooked meat products ready for consumption, excluding meat and meat products in hermetically sealed containers, the microbiological limits as stated below should be negative for Salmonella spp., Campylobacter jenuni, Listeria monocytogenes;-

REGULATIONS FOR THE IMPORTATION OF PORK AND PARTS THEREOF FROM OVERSEAS INTO OF SARAWAK, MALAYSIA (Effective 3 April 2023)

A. Animal : Pork and parts thereof

B. Country of export : Overseas

C. For the purpose of : Human Consumption

D. Regulation for Importation: -

1) Import Permit

Each consignment pork part thereof shall be accompanied by a valid import permit issued by the State Veterinary Authority, Department of Veterinary Services Sarawak permitting entry into Sarawak, Malaysia.

2) Veterinary Certification

The consignment of pork meat or pork products shall be accompanied by a veterinary health certificate issued by a competent Veterinary Authority of the exporting country within 30 days of export certifying that;

- a) The pork meat or pork products were derived from animal that was slaughtered and processed in an abattoir (the name, address and establishment number of the abattoir must be clearly stated in the certificate) which has been approved for export by the Department of Veterinary Services, Malaysia and has been under continuous supervision of the Veterinary Authority of the exporting country.
- b) The country or part of the country or state of origin of the pigs from which the products were derived, has been free from Foot and Mouth Disease (FMD), Anthrax, African Swine Fever, Classical Swine Fever (hog cholera) and Swine Vesicular Disease for the past twelve (12) months prior to and till the date of export.
- c) The pork meat or pork products were derived from an accredited farm (the name and address of the farm shall be clearly stated in the certificate) and under continuous supervision of the Competent Veterinary Authority of the exporting country.
- d) The pork meat or pork products were derived from farm certified to be free from Swine Vesicular Disease and no case of infectious or contagious pig diseases have been diagnosed or occurred at the farm prior to shipment of the pigs for slaughter.
- e) The pork meat or pork products were derived from pigs that have been subjected to antemortem and post-mortem inspection and were found to be healthy and free from any clinical sign of infectious or contagious disease at the time of slaughtering / processing.
- f) The pork meat or pork products have been processed, packed and stored under sanitary condition and do not contain any preservatives, colouring matter, residue or any foreign substance or harmful material injurious to health and that every precaution had been taken to prevent contamination during processing, packing, storing and handling prior to export.
- g) The pork meat or pork products destined for export to Malaysia are safe, wholesome and fit for human consumption.

3) Transportation and Landing Place

- a) The vehicle / container used for the transportation of frozen or chilled pork meat or pork products must be in hygienic conditions and refrigerated.
- b) Each consignment of pork meat or pork products imported into Sarawak shall be carried by ship or aircraft or any vehicle direct to the prescribed landing place or any other port or airport in Sarawak.

4) Inspection at the Point of Entry in Sarawak

- a) All officials' documents required under this importation shall be surrendered for verification to the State Veterinary Authority (SVA), Department of Veterinary Services Sarawak or to any authorised officer of SVA, on arrival at designated port or airport in Sarawak.
- b) Each consignment of pork meat or pork products imported into Malaysia shall be subjected to veterinary inspection by an authorised officer of the SVA. Random samples will then be collected for laboratory testing and SVA has the right to reject, destroy or further detain any consignment when deemed necessary.

5) Other Conditions

a) State Veterinary Authority, Department of Veterinary Services Sarawak has the right to inquire for any

- document or detailed information from the parties concerned. In the event that applicants (importers or exporters) fail or unable to provide or to comply with any of the above requirement, the SVA has the right to reject or not to approve the application.
- b) All cost incurred for inspection of the abattoir by the official(s) from the SVA prior to approval shall be borne by the parties concerned.

6) Suspension of Import

State Veterinary Authority, Department of Veterinary Services Sarawak may suspend the importation of the products either temporarily or permanently in the event of disease outbreaks or suspected disease outbreaks or in case of importation in contravention of the above regulations.

1) Import Permit

Each consignment cooked and Heat-processed pork products shall be accompanied by a valid import permit issued by the State Veterinary Authority, Department of Veterinary Services Sarawak permitting entry into Sarawak, Malaysia.

2) Veterinary Health Certification

Each consignment of cooked and heat-processed pork products shall be accompanied by the following certificates dated within thirty (60) days of import: -

a) Veterinary Health Certificate signed by competent veterinary officer certifying: -

- i) That the products are exported from Foot and Mouth Disease (FMD) & African Swine Fever (ASF)-free country/zone, the products have been subjected to heat treatment that is sufficient for inactivation of FMD & ASF virus in accordance with World Organization For Animal Health (WOAH) guidelines.
- ii) The products were derived from animals which have not been swill-fed.
- iii) The pork products were derived from animals which have passed ante-mortem and post-mortem inspection and found to be free from any signs suggestive of and tested free from ASF and FMD.
- iv) The ante-mortem and post-mortem inspections have been carried out by veterinarians or meat inspectors under direct supervision of government veterinarians.
- v) The retort processed meat products (e.g. canned meat) have been heat treated to at least 120°C (sterilising process with sterilising value of not less than Fo3) to sterility in hermetically sealed containers and are stable on-shelves at ambient temperatures.
- vi) That the cooked and heat-processed pork products were processed, packed and stored under sanitary condition and do not contain any preservative or colouring matter not permitted under the Food Act, 1983 and Food Regulations, 1985 and residue or any foreign substance or harmful material injurious to health and that every precaution had been taken to prevent contamination during processing, packing, storing and handling prior to export;
- vii) That the cooked and heat-processed pork products are wholesome and fit for human consumption.

3) Meat Safety and Quality

a) For cooked meat products ready for consumption, excluding meat and meat products in hermetically sealed containers, the microbiological limits are as stated below and should also be **negative** for Salmonella spp., Campylobacter jejuni, Listeria monocytogenes;-
